LIST OF ECOLOGICAL SPECIFICATIONS ACCEPTED BY THE HOVIMA CHAIN

Our environmental policy in **HOVIMA** forces us to take measures and approve criteria to buy products that do not harm our environment. Reducing the volume of waste is one of the goals we have set ourselves. For this reason we have approved some general responsible environmental purchasing criteria, which must be respected and followed by our suppliers and are the following:

Regarding the packaging

- · Recycled product
- Product in returnable containers
- Product that generates recyclable waste
- Waste that is expected to be recycled in the short term
- · Theoretically recyclable waste

Regarding the nature of the products

- EEC labeling rules
- Eco labeling standards in Spain (if they cannot follow those of the EEC)
- Autonomous labeling rules (if applicable)

Perishables goods

- Action in case of emergency. Food products presented, free of pesticides and insecticides wich have been germinated in a transgenic manner
- Meat products made without using chemical products prohibited by current health legislation
- Foods such as meat or fish must carry the appropriate certificates of hygienic-sanitary control of health with all registered data.

Non-Perishable godds

- · Biodegradable products
- Organic products
- Product free of CFC refrigerant harmful to the ozone layer
- Labeling of all so-called "dangerous" products such as chlorine, cleaning product, ph's, among Others
